For the first time in history, the number of overdoses has surpassed automobile fatalities. The rise in use of Opioids,

pain killers, heroin, and marijuana in North Macomb County is an epidemic that no parent in our community can afford to ignore. During heavy snowfalls please do not leave your cars in the street, so the DPW can provide adequate snow removal. Also the please have snow removed from sidewalk within 48 hours. We have been getting a number of complaints regarding residents putting trash out early, please put trash out the night before.
